Job Purpose:

This role fosters a vibrant growing parish culture through teaching students K through 8th grade, including sacramental preparation, as well as adult faith formation, including OCIA. This position collaborates closely with the Pastor, Deacon, Religious Formation Commission, volunteers, and parishioners to promote spiritual growth and Catholic identity across a diverse community.

Duties & Responsibilities

- Administer implementation of catechetical programs including Sacramental Preparation.
- Manage student registrations, parent engagement and Catechist formation.
- Recruit, train, supervise, support and evaluate all catechists and Youth Ministry volunteers.
- Create curriculum and assist catechists in developing lesson plans.
- Accompany Catechists and Students each week they meet for faith formation classes.
- Teach and substitute teach classes when necessary.
- Engage parents in their students' faith formation journey.
- Coordinate the Confirmation Retreat.
- Coordinate the First Communion Retreat.
- Coordinate and facilitate annual VBS.
- Prepare Sacramental liturgies.
- Plan and facilitate Youth Group events.
- Develop and teach Adult Faith Formation class.
- Publicize RF events in the bulletin, through Flocknote, Mass announcements, flyers and parish website.
- Develop and implement the OCIA process per Diocesan requirements.
- Coordinate the Holy Saturday Preparation Rite for OCIA Candidates.
- Execute other duties as assigned.

Qualifications

- Possess a Degree in Religious Education or a related field.
- Be a practicing Catholic who supports the mission, philosophy, objectives, policies and teachings of the Roman Catholic Church and the Diocese of Joliet.
- Demonstrate knowledge of Catholic doctrine, Tradition and theology.
- Have experience working with youth in a ministerial setting.
- Pass a background check and adhere to all Protecting God's Children protocols.
- Demonstrate skills in organization to effectively plan, develop, facilitate and implement events and Catechetical programming within the parameters of the Catholic Church.
- Be proficient in Microsoft Office, Google Docs, Constant Contact, Parish Data System, Church Data System, Parish telecommunications, and media management.
- Excel in written and verbal communication skills, including conflict management skills.
- Be able to facilitate large and small groups.
